

ATTENTION PART B CLAIM SUBMITTERS

After successful pilot testing of our new on line Part B claims submission system, the Program is offering this capability to the remaining Part B provider/submitters. See table below for eligible provider types for this new submission system.

January 11, 2017 is the start date for other provider/submitters to use this capability.

We need the below specific provider information to be emailed to mdh.emedicaidmd@maryland.gov to validate access. Providers/Submitters need to:

- Email the names and email addresses of the eMedicaid Administrators (the staff member identified as being responsible for assigning your individuals/staff members to eMedicaid i.e. lookup capability).
- Provide your 9 digit Medicaid Provider ID Numbers for the Provider locations that will have claims submitted.

Please limit this access to two (2) staff and provide the staff member's names.

If you need to validate or identify the Administrator for your organization, please click on "Who is my site administrator?" link on the left hand side after logging in to the eMedicaid site or email mdh.emedicaidmd@maryland.gov and the current information on file will be provided.

You will receive the below eMedicaid invite to begin your claim submissions once the necessary information is received:
